Website owner, the offering, and binding of Terms

This website is owned and operated by Anisha of The Real Fair Foods. These Terms set forth the terms and conditions under which you may use our website and services as offered by us. This website offers visitors fresh delicious food at a fair price. We also provide catering, themed character's, event planning and set up, water and bouncy houses. By accessing or using the website of our service, you approve that you have read, understood, and agree to be bound by these Terms.

Who can use your website; what are the requirements to create an account?

To use our website and/or receive our services, you must be at least 18 years of age, or of the legal age of majority in your jurisdiction, and possess the legal authority, right and freedom to enter into these Terms as a binding agreement. You are not allowed to use this website and/or receive services if doing so is prohibited in your country or under any law or regulation applicable to you.

Key commercial Terms offered to customers

When buying an item, you agree that: (i) you are responsible for reading the full item listing before making a commitment to buy it: (ii) you enter into a legally binding contract to purchase an item when you commit to buy an item and you complete the check-out payment process.

The prices we charge for using our services /for our products are listed on the website. We reserve the right to change our prices for products displayed at any time, and to correct pricing errors that may inadvertently occur. Return and refund policy

For any undamaged product, simply return it with its included accessories and packaging along with the original receipt (or gift receipt) within 7 days of the date you receive the product, and we will exchange it or offer a refund based upon the original payment method (excluding food and beverages. In addition, please note the following: (i) Products can be returned only in the state in which they were originally purchased; and (ii) the following products are not eligible for return: food & beverages. Retention of right to change offering

We may, without prior notice, change the services; stop providing the services or any features of the services we offer; or create limits for the services. We may permanently or temporarily terminate or suspend access to the services without notice and liability for any reason, or for no reason.

Warranties & responsibility for services and products

When we receive a valid warranty claim for a product purchased from us, we will either repair the relevant defect or replace the product. If product is damaged a fee will be assessed at the time or return with No Refund. If we are unable to repair or replace the product within a reasonable time, the customer will be entitled to a full refund upon the prompt return of the product to us. We will pay for shipment of repaired or replaced products that are defected not damaged to customer and customer will be responsible for return shipment of the product to us. If not able to return will pick up with a fee applied for distance. If items are not returned for an event the full purchase price will be deducted and charged to payment method. If payment method declines, we have the right to use any legal action. All property that is being rented, or items used for event or setup must be returned within 24 hours after event or it will be marked as stolen/theft unless you have written permission from us.
